<b>3</b>	<p><b>TYLER update</b>          [Redacted] updated the group on TYLER work:          TYLER has started work on the Independent Living Skills course.          Issue with accessing the YAB grant in which TYLER were successful. To be able to draw down the funding, TYLER have two options:          a) to set up and register as a constituted group or,          b) sit under/ be affiliated with another charity/group          [Redacted] has concerns about TYLER doing option a, the subgroup suggested option b would be better and suggested linking with Lollipop or the Thirteen project.[Redacted] to explore.
